# Respecting Your Privacy

I am committed to protecting and respecting your privacy. This Policy explains to you how I use any personal information I collect from you when you email me, use my website: www.communicatinghands.co.uk, or when you provide me with any personal data. I keep certain information when you contact me or visit my website or when you purchase services from me and recognize the importance of keeping that information secure and letting you know what data I have and what I will do with it. You may choose to provide me with information that is considered personal data. The term "personal data" as used in this Policy refers to information such as your name, e-mail address, mailing address, telephone number, or any other data that can be used to identify you.

Data Controller Information: Communicating Hands is owned by me and I am the Data Controller, ensuring that I manage your data fairly and securely. If you contact me, book me for an assignment or otherwise take any action that involves providing personal data, you consent to this Policy, as well as to the storage of your data by me and to the collection, processing, transfer, and storage of your personal data by me\_and necessary third party applications in various countries as needed to process your requested action.

What Information Do I Collect About You: I collect information from you when you fill out a contact form on my website at communicatinghands.co.uk, or when you send me an email, and when purchase service from me. When someone visits you а www.communicatinghands.co.uk I use a third-party service, Google Analytics, to collect standard internet log information and details of visitor behaviour patterns. I do this to find out things such as the number of visitors to the various parts of the site. This information is only processed in a way which does not identify anyone. I do not make, and do not allow Google to make, any attempt to find out the identities of those visiting our website. I will make it clear when I collect personal information and will explain what I intend to do with it. For example your name and address will be stored so that I can send future invoices. With your permission I may also email you with a list of my latest available dates using the email address you have provided.

The type of data I hold may include:

- -Name
- -Email address
- -Telephone Number
- -Your company name

Any feedback you have given me

- -Banking information if payment is processed through BACS
- -Preparatory Information you provide me

#### **How Will I Use the Information About You?**

I use the information you provide to process your invoices, book dates in my diary and request feedback.

You may receive an email with my latest availability for work if you have joined my mailing list, unless you have opted out of receiving that marketing.

If you are currently receiving that email from me and would like to unsubscribe you can do so by emailing me: contact@communicatinghands.co.uk

I will not share your personal data with other companies for marketing purposes. Should a client/colleague ask for your contact details I will ask your permission before passing them on.

## **Lawful Basis for Processing Data**

Services at communicating hands use our customers' data when I need to do so in order to carry out the contract we are about to enter/have entered into with you. When you purchase form me or when you book my services, I need certain data to be able to undertake the booking and provide you with the service you have requested.

I may also request and collect feedback from clients which I use to help me continue to improve my performance.

If you have joined my mailing list, you will receive regular emails from me, stating my availability. You have the right to unsubscribe, by replying to the email, or you can ask to be removed by sending an email to <a href="mailto:contact@communicatinghands.co.uk">contact@communicatinghands.co.uk</a>.

#### **Access to your Information and Correction**
